> "What this House needs is parity of democratic rights with the rest of the United Kingdom. There are components of Scotland and Wales's settlements that we take for granted. The very right to have an opposition is taken for granted in Edinburgh and Cardiff; indeed, it is taken for granted across the democratic world. Yet here, even that basic democratic right is denied in these institutions.

On top of that, the people of Scotland and Wales have the basic democratic right to change their government; to vote a party that they are disillusioned with out of government. Of course, because of the import of an unworkable mandatory coalition, we do not even have that right here. If the Prime Minister is talking about constitutional reform, he should start at the point where one infuses the democratic imperatives into the structures that we have in this House.

"Let me be very clear: the enemies of Stormont are those who refuse to contemplate the democratisation of Stormont. That is who they are."

Unionists Need To Face Up To Reality—Stormont Cannot Deliver

Commenting on the current financial crisis facing Northern Ireland, Jim Allister MLA calls for unionists to wake up to the reality facing them:

"The current crisis over Stormont's budget illustrates that the Belfast Agreement is based on a flawed premise and can never deliver good government for the people of Northern Ireland.

"The failure of the Executive to agree on welfare reform leaves us looking over a financial precipice with Ministers across the political spectrum warning of dire consequence for essential services, particularly when it comes to the Health Service.

£3m of Health Funding Spent on Interpreters

TUV leader Jim Allister has established through an Assembly Question that £8000 every day of health service funds is going on paying interpreters, giving an annual cost of almost £3 million.

The TUV leader has also established that 5% of pupils in Northern Ireland schools do not have English as their first language, with the percentage topping 10% in South Belfast and 9.5% in Fermanagh & South Tyrone.

Commenting Jim Allister said:-

"In a climate of spates of racist criminal attacks which must be met with the full rigour of the law – it is difficult sometimes to draw attention to issues of which the public need to be aware. These figures graphically illustrate the impact of the EU's open door immigration policy within this part of the UK. In the debate about immigration we seldom hear of the ancillary costs in education and health, but, plainly, they are huge, even in the incidentals of providing interpreters in our hospitals.

"The face of several constituencies is changing dramatically, with South Belfast, Fermanagh & South Tyrone and Upper Bann having in or about 10% of schoolchildren not having English as their first language.

"The geographical correlation between health spend on interpreters and high levels of immigrant children in our schools is obvious with the Southern

Health Trust spending £1.3m per annum on interpreters."

Concluding, North Antrim MLA Jim Allister commented:

"Migration has been a feature of life for centuries, but hitherto nation states have exercised control through operating the immigration policy suited to their needs. But not anymore, because now the EU controls our immigration policy and operates a completely open door policy across Europe. Hence, the disproportionate upsurge in westward migration and the resulting pressures on our health, welfare and education budgets. It is only outside the EU that the UK can reassert control over its immigration policy."

"Yet Allister's one man opposition in Stormont has won him respect – even in unlikely quarters – and it would be no surprise to see him poll strongly. He's the one to watch. '

Allister Comments on Anniversary of IRA Tactical 'Ceasefire'

No Money for HET, but £4000 per week for Wining and Dining

A key area of TUV success has been the constant unearthing of wasteful practice within government. Ranging from thousands of pounds spent on mints to keep our MLAs sweet—to the squander of millions on North-South Bodies.

Particularly when facing budgetary cuts—wasteful practice should be the first thing to go.

Responding to suggestions that budget cuts may see the HET axed, TUV leader

Jim Allister said:-

"This further downgrade of the value of innocent victims in our society comes in a week that I received an Assembly Answer which revealed that last year, 2013/14, the PSNI spend £218,800 on hospitality. Of course, £218,800 wouldn't fund the HET, but it points to a less than rigorous approach to austerity in some quarters if over £4000 a week can be spent on wining and dining. "Moreover, I must ask how much is to be spent on the dedicated investigation into the pursuit of criminal charges out of Bloody Sunday and by how much is this historically-linked expenditure to be cut, or, is it only the innocent victims of terrorists who are to feel the draught?"

Concluding, Allister stated:

"Stormont needs to prioritise its spending or the people of Northern Ireland would be better off without it."

The devolution of Corporation Tax has been much vaunted by all the executive parties as some kind of magic wand. TUV has long said that Stormont is not fit to have any tax variance powers and that any lowering of Corporation Tax would leave a significant gap in the current budget.

Jim Allister MLA on this subject said:

"The very talk of £200m cuts has put Stormont into a tailspin. Think what top-slicing £400-£750m off the block grant would do, in order to pay for the bauble of corporation tax.

Madness to Devolve Corporation Tax

"Stormont can't handle the powers it has. It would be madness to give it any more. Nor would devolving corporation tax really transform our economy because most of our small/ medium employers – the backbone of our economy – would not benefit."

Continuing, Jim Allister said:

"The financial crisis at Stormont is far too serious and its dysfunctionalism far too endemic to be thinking of massaging the egos of its failing ministers by gifting them fiscal powers.

"Stormont has failed every test in providing good governance, and it cannot be trusted to have any more powers.

"Preserve us all from taxraising powers for this failed Stormont."

Responding to comments by the outgoing head of the Northern Ireland Tourist Board TUV Castlereagh East councillor Andrew Girvin said

"TUV has long argued that Northern Ireland is getting a poor deal from Tourism Ireland. In January last year, for example, Jim Allister pointedly asked the tourism Minister if she believed Northern Ireland's tourism promotion and interests are best served by being a subservient part of Tourism Ireland and argued that we would be better standing on our own feet.

"The comments of the outgoing head of the Northern Ireland Tourist Board, Alan Clarke, are therefore no surprise to TUV.

Tourism Ireland Not Delivering for Northern Ireland

"Marketing Northern Ireland as a standalone destination, particularly when it comes to people coming over for short breaks from Great Britain, makes sense. Visitors from the rest of the UK are, apart from anything else, spared the hassle of having to change their currency before coming over."

Continuing, Cllr Girvin said:

"Having to market the island of Ireland as a single destination simply doesn't add up and it is obvious that taxpayers in Northern Ireland are being ridiculous short-changed when one considers that we put up 1/3 of the money to run Tourism Ireland and yet

Northern Ireland is only getting around 10 – 11% of the holidaymakers.

"Northern Ireland has a fantastic tourism product to sell if it wasn't encumbered by the shackles of Tourism Ireland – a politically contrived body. The success of our golfers has also presented us with a unique marketing opportunity."

Concluding, Cllr Girvin backed Northern Ireland to succeed:

"I remain convinced that Tourism Ireland isn't up to the job of delivering for the Northern Ireland tourist industry and needs to go along with all the other useless North-South

bodies.

"It is about time that Northern Ireland had the opportunity to sell itself, instead of contributing to the promotion of the Republic of Ireland at the expense of our own tourist destinations.

"As ever, TUV will fight tooth and nail to highlight waste and bad practice within government, whether at local or national level. I want to see Northern Ireland prosper and to do so we need to reassess where taxpayers money is going and what Northern Ireland gets back.

"TUV can be trusted to put Northern Ireland first."

OFMDFM Runs Up £2.6m Credit Card Bill 19 months after asking OFMDFM how much their staff had expended on procurement credit cards, TUV leader Jim Allister has finally got an answer to his Assembly Question.

He has unearthed that 12 staff in OFMDFM operate such cards and that since 2007 a staggering £2.6m has been racked up on them. It seems they have been mainly used for 'travel and accommodation expenses'!

Commenting Jim Allister said:

"The fact that it took the

Joint First Ministers 19 months to get over the embarrassment of revealing this information is significant in itself. And well might they be embarrassed in these times of severe austerity.

"A key concern in this regard is what level of accountability and oversight operates in respect of this expenditure. I am calling on OFMDFM to publish a full inventory of all these purchases. Occasional and emergency spend while travelling on credit cards might be understandable, but running up a bill of

over £2.6m does raise serious questions as to the application of procurement checks and balances. It is now up to OFMDFM to provide full transparency on this issue."

Concluding, Jim Allister said:

"This is yet another example of the disregard showing to transparency and accountability. It is the taxpayer that is paying this substantial credit card bill and it is the taxpayer that needs assured that it has been accrued for proper purposes."
